On the **FOURTH Sunday of the Month**, the Webb **Park Certified Farmers Market and Specialty Faire** offers market space to vendors that are not otherwise participating in our weekly Farmers Market. **THIS IS AN OUTDOOR EVENT**

The event is a part of the **Webb Park Specialty Faire** and will run at the same time as the **Weekly Farmers Market & Specialty Faire**, 10am-4pm.

The fee is a flat \$50 for a ten by ten foot space; we do NOT limit duplication of products, services or brands.

- ❖ This event is open to artists and crafters. Currently we are also considering applications from Handcrated Artisans of all kinds
- ❖ Our emphasis is on providing local artists with an opportunity to display and offer their artwork in the community.
- ❖ This is ideal for hobbyists and artists that do not otherwise have the opportunity to occasionally display their works.
- ❖ Vendors who participate in our monthly events are also considered for our weekly market wait-list, and should space become available or as we expand and decide to increase the quantity and variety of products included in the weekly farmers market, those are the vendors we will look to first.

Only one-vendor per booth-space will be permitted. Only the products included on the approved vendor application may be offered.

Complete applications, the **ARTS & CRAFTS checklist**, and copies of all documents must be submitted, reviewed and approved by the Market Managers in advance.

A \$10 deposit must accompany your application; the \$10 will be applied to your fees due on the day of the event. Deposits are non-refundable and cannot be applied toward any other date.

Applications must include a copy of your Sellers Permit (sales tax) and any certifications, permits, or licenses used in connection with the products and/or services you plan to offer.

We will NOT screen or review new applicants on the morning of the event.

The market does not provide canopies, tables, chairs or access to power; we provide only the 10x10 space for you to set up in.

Vendors are responsible for providing everything used in the set-up and operation of their market display.

*please note:* our events are held in Webb Park and displays will be set up on the grass along the walkway that winds through the Park. Vendors must consider the following:

- Grassy areas may be wet, especially in the morning. A tarp to lay your items out on while setting up is suggested.
- Grassy surfaces that appear level may still have areas with dips and bulges.
- Some areas may be slightly sloped or not perfectly level; blocks to level table surfaces and/or adjusting canopy legs shorter in the back may be necessary.
- We cannot anticipate sunny/shady areas throughout the day. If your products are sun-sensitive, you will need to plan accordingly to create your own shade as needed.

**Webb Park** sits along the I-15 Freeway, tucked quietly behind the businesses along the West Side of Bernardo Center Drive (Rancho Bernardo, San Diego) from Avena Place at the South end of the Park, to Bernardo Plaza Court to the North of the Park. The exits on the I-15 at Bernardo Center Drive (south of the Park) and Rancho Bernardo Road (North of the Park) provide convenient freeway access.

Beautiful **Webb Lake** sits between Pearl Chinese Cuisine (11666 Avena Place) and the *Courtyard by Marriott* (11611 Bernardo Plaza Court) and provides the southern anchor for the **Webb Park Certified Farmers Market and Specialty Faire**.

**Webb Park** has no parking of its own, however convenient and ample parking is available on Sundays in any of the bordering parking lots.

**Webb Park** and the **Webb Park Certified Farmers Market and Specialty Faire** can be found through the parking lots located behind:

- US Bank (16816 Bernardo Center Dr),
- California Bank & Trust (16796 Bernardo Center Drive),
- Sylvan Learning Center (16776 Bernardo Center Dr), and
- the Medical Dental Building (16766 Bernardo Center Dr).

Parking is also available at the *Courtyard by Marriott* (11611 Bernardo Plaza Court), and the **Webb Park Certified Farmers Market and Specialty Faire** can be entered by walking through the **Courtyard by Marriott** lobby.
